Warranty Information

Leggett & Platt will warrant the mattress, air bladder, and air bladder valve to the original owner for a three year period and the motor for a one year period. This warranty only covers defects in material or workmanship.

When a replacement is needed, it will be sent to the desired location of the manufacturer. The manufacturer will be charged a replacement charge if the replaced product is not returned to Leggett & Platt within 30 days. When the replaced part is received and found defective, this charge will be credited.

In no event shall Leggett & Platt be responsible for disassembly, installation, or other labor charges. In addition, Leggett & Platt will pay the shipping to the manufacturer or customer if the replaced product is deemed defective. This applies only to shipments within the U.S. and only during the warranty period.

This warranty does not apply to damage to components occurring after delivery to manufacturer, including, without limitation, damage resulting from faulty installation or assembly not in accordance with Leggett & Platt specifications or misuse of the furniture in which the components are installed.

THE REMEDIES PROVIDED IN CONNECTION WITH THIS LIMITED WARRANTY ARE EXPRESSLY IN LIEU OF ANY OTHER REMEDIES PROVIDED UNDER ANY OTHER EXPRESS OR IMPLIED WARRANTY, INCLUDING ANY WARRANTY BY MODEL OR SAMPLE AND ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS, AND OF ANY OTHER OBLIGATIONS ON THE PART OF Leggett & Platt IN NO EVENT SHALL Leggett & Platt BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. NO MODIFICATION OF THIS WARRANTY SHALL BE EFFECTIVE UNLESS IT IS IN WRITING AND SIGNED BY AN AUTHORIZED REPRESENTATIVE OF Leggett & Platt.

This warranty extends only to the manufacturer. If manufacturer gives a warranty to consumers different from the warranty extended herein, Leggett & Platt shall not comply with any portion of that warranty which differs from, modifies or alters Leggett & Platt's warranty.

Effective June 1, 2007

This supersedes all previous warranties.

Air Dream Warranty Fulfillment Procedures

1. The consumer will contact the retail store from which the sofa sleeper was purchased. The retailer will then contact the furniture manufacturer with a defective claim on the pump, air bladder, or valve assembly.
2. The furniture manufacturer will contact the L&P facility from which the Air Dream mattress was obtained, filing a defective claim.
3. L&P will ship the requested replacement part, normally within 24 hours. A prepaid return shipping label will also be included in the box.
4. Using the prepaid return shipping label, the manufacturer or retailer will return the defective pump, air bladder, or valve assembly to L&P. The part must be returned within 30 days to avoid charges.
5. L&P will review each returned part for defects and/or abuse and document these findings.
